<i>If the hosting Club cancels the show, the Club will be responsible for any non-refundable expenses incurred by the judge in connection with the assignment. If the judge cancels the assignment, the judge will be responsible for any non-refundable expenses incurred by the club in connection with this assignment.</i>			
<i>In the event of a border closure due to COVID-19, the hosting Club undertakes to provide five (5) days homestay accommodation to any visiting judge unable to travel home and will do all that is possible to ensure they can travel home as soon as possible. (The hosting Club will bear any additional travel costs).</i>			
<i>In the event of a border lockdown, judges will liaise with the hosting Club in the first instance to discuss any out-of-pocket expenses.</i>			
<i>All Interstate Judges will have personal travel, and if required medical insurance.</i>			
<i>To be reimbursed for expenses incurred, receipts must be provided. This may cover, transportation costs to and from the show, entry visa applications, and accommodation as per the agreement.</i>			
<i>Local judges will be given a petrol payment by the hosting Club, as determined by GCCFSA.</i>
