

- COVID-SAFE GUIDELINES TO BE READ BY ALL EXHIBITORS
- VACCINATION CERTIFICATES MUST NOW BE PROVIDED AT VETTING FOR ALL KITTENS. PLEASE ENSURE
 THAT KITTENS CAN BE IDENTIFIED ON THE VETTING CARD AND THE ORIGINAL STICKERS AND VET
 SIGNATURES ARE AVAILABLE.
- EXHIBITORS MUST PROVIDE A COVERED LITTER TRAY FOR EACH CAT TO AVOID UNNECESSARY ODOURS IN THE HALL.
- NO EXHIBIT SHALL BE REMOVED FROM THE SHOW PRIOR TO THE CLOSE OF THE SHOW WITHOUT THE PRIOR PERMISSION OF THE SHOW MANAGER.
- ALL EXHIBITS MUST HAVE THEIR CLAWS TRIMMED.
- SHOW MANAGEMENT RESERVES THE RIGHT TO CHANGE THE JUDGING ASSIGNMENTS DEPENDING ON THE NUMBER OF ENTRIES.
- Please note that the venue rules state NO SMOKING or chewing gum on the grounds. Please help us by observing these rules. Thank you.
- PLEASE PARK YOUR CAR IN MARKED AREAS ONLY.

The 2020 GOLDEN AWARDS FINAL will now be held in July 2021.

Any cats qualified in 2019/2020 will be eligible for the 2021 Final and do not need to qualify again*.

*Unless qualified as an entire and now competing as a neuter, as per the Golden Awards Rules.

*Any cat reserved, may need to qualify to enter the final as per the Golden Awards Rules.

GCCFSA COVID-SAFE GUIDELINES

GCCFSA will:

- Keep an attendance record, including the name, phone number or email address, and date and time of people attending the cat show, for the purpose of contact tracing in relation to COVID-19.
- Maintain and encourage others to maintain the physical distancing principle of at least 1.5 metres separation, where possible:
 - This includes between groups within each room.
 - o At entry and exit points.
- Consider venue layout and move tables and seating to comply with physical distancing (1.5m separation) and density requirements (1 person per 2 square metres).
- Dedicate separate entry and exit doors from separate rooms, and pathways to encourage "one-way traffic" where possible.
- Minimise mixing between separate rooms or groups of people as much as possible.
- Display signage at the venue entrance to instruct members of the public (and staff) not to enter if they are unwell or have COVID-19 symptoms.
- Monitor compliance with physical distancing requirements, with particular regard to areas where members of the public might congregate.
- Encourage and support downloading of COVID-Safe App.
- Clean bathrooms more frequently than lower traffic areas, especially taps, door handles and other frequently touched points.
- Provide hand sanitiser on entry and exit of the premises.

Exhibitors will:

- Declare any contact with COVID-19 by completing the COVID-Safe Questionnaire with their entry, including the following statements:
 - They have not had any flu-like symptoms within the last two weeks
 - o They have not been overseas or interstate within previous two weeks
 - They have not been in close contact within anyone diagnosed with COVID-19 within the last two weeks
 - They do not feel unwell.
- Practice safe hygiene by making use of the hand sanitiser provided by the show management, throughout the show.
- Practice physical distancing requirements of at least 1.5 metres separation, where possible.
- Maintain physical distancing from judges and stewards at all times.
- Should an exhibitor become unwell with COVID-like symptoms prior to the show, it is important that they do not attend. A refund may be possible.
- Should an exhibitor become unwell with COVID-like symptoms during the show, it is important to advise show management immediately. You may be asked to leave the show hall and a COVID-19 test will be required to ensure the safety of all exhibitors.

*Cosgrove Hall has a COVID-Safe capacity of 300 people, however this will be limited to EXHIBITORS ONLY. Public will not be allowed at this show. The Hall will be set up as a semi-closed show with in-line judging and a separate area for exhibitors. A presentation area for judges to present their TOP AWARDS will be provided to ensure exhibitors are able to view their cats and kittens being judged.
