



**OPEN STYLE JUDGING – IN-LINE VETTING – EXHIBITS WILL BE REFUSED
ENTRY AFTER 8.30 AM**

- ANY EXHIBIT WHICH IS SHOW IS CONSIDERED TO BE UNDERSEDATION WILL BE DISQUALIFIED (8.10)
- ALL EXHIBITS MUST HAVE ALL CLAWS TRIMMED (7)
- AT VETTING IN, ANY EXHIBIT SHALL BE REJECTED BY THE VET THAT SHOWS SYMPTOMS OF, OR MAYBE SUFFERING FROM, ANY CONTAGIOUS DISEASE, HAS EXTERNAL PARASITES, IS DIRTY AND UNFIT FOR EXHIBITION: OR ANY ADULT MALE CAT WHICH IS MONORCHID OR ANY FEMALE CAT OBVIOUSLY IN KITTENS (8.2)
- EXHIBITORS MUST PROVIDE A COVERED LITTER TRAY FOR EACH CAT TO AVOID UNNECESSARY ODOURS IN THE HALL. To be placed under the cats show cage.
- USED LITTER TRAYS ARE NOT TO BE EMPTIED INTO ANY OF THE SHOWS GARBAGE BAGS
- NO EXHIBIT SHALL BE REMOVED FROM THE SHOW PRIOR TO THE CLOSE OF THE SHOW WITHOUT THE PRIOR PERMISSION OF THE SHOW MANAGER.
- SCANNING OF MICROCHIPS WILL TAKE PLACE OF ALL KITTENS
- VACCINATION CERTIFICATES MUST BE PROVIDED AT VETTING IN FOR ALL KITTENS SHOWING WITH AT LEAST 2 X F3 VACCINATIONS COMPLETE. PLEASE ENSURE THAT KITTENS CAN BE IDENTIFIED ON THE VETTING CARD AND THE ORIGINAL STICKERS AND VET SIGNATURE AVAILABLE
- GCCFSA REQUIRES EXHIBITORS TO ABIDE BY THE RULES AND CODE OF ETHICS. ANY ISSUES MUST BE DEALT WITH ON THE DAY BY THE HOSTING CLUB.
- PLEASE PARK YOUR CAR IN MARKED BAYS ONLY
- SHOW MANAGEMENT RESERVES THE RIGHT TO CHANGE THE JUDGING ASSIGNMENTS DEPENDING ON THE NUMBER OF ENTRIES.
- Please note that the venue rules state NO SMOKING or CHEWING GUM on the grounds. These rule will be reinforced.
